**EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHED AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/ COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR. WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP. SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS. EXHIBITORS IN WALK/TROT/JOG CLASSES ARE EXEMPT FOR AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS. EXHIBITORS IN LEADLINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)**

**SHOW ENTRY INFORMATION**

1. Entries **MUST** be submitted on the Official Entry Form for this Show. No entries will be taken over the telephone. If additional entry forms are required, photocopy BOTH SIDES of the entry form.
2. **Complete NAME and ADDRESS of the Registered Owner Must appear in the space for Owner Information – ONE OWNER ONLY per form.r form.**
3. A copy of the REGISTRATION PAPERS (FRONT AND BACK) OF EACH HORSE showing proof of ownership must be submitted with entry form at the time of making entry. In case of a sale or lease, it is required that a contract of sale or lease, or statement from the owner be submitted with the copy of registration papers. (Exception: Horses under one year of age that are eligible for registry or registration applied for.) (Exception: All Breed entries)
4. HORSES ENTERED IN AMATEUR OWNER AND JUNIOR OWNER CLASSES MUST BE REGISTERED IN THE NAME OF THE COMPETITOR OR MEMBER OF THE COMPETITOR'S FAMILY (as defined in USEF GR123, Page GR7). If showing as an Amateur, member to insert your relationship to the owner on the entry form. CONTRACT OF SALE OR BILL OF SALE WILL NOT BE ACCEPTED. The sale of a horse does not eliminate this registration requirement. (Horses registered in a farm/ranch/syndicate/partnership/corporation name may be shown in Amateur Owner classes provided all owners are members of the same family.)
5. EVERY OWNER, EXHIBITOR, TRAINER, COACH, RIDER/DRIVER/BREEDING HALTER HANDLER or his/her agents **MUST SIGN** the entry blank. In case of a rider/driver/handler under 18, his/her parent or guardian, or if not available, the trainer must sign the entry blank on the minor's behalf. A minor cannot sign for him/herself. (Trainer is "any adult who has the responsibility for the care, training, custody or performance of a horse"). Junior Owners are not eligible to sign as trainer – Adult **MUST** sign as Trainer. If the Owner has no trainer, owner must sign in trainer sections also.
6. Include COPIES of CURRENT AHA *COMPETITION* LEVEL MEMBERSHIP CARDS FOR EVERY TRAINER, RIDER, HANDLER, DRIVER, JUNIOR OWNER AND at least ONE CURRENT OWNER. If the above cards are NOT submitted, appropriate fees **MUST** be paid. If you do not submit a copy of your membership card, you may join the Comstock Arabian Association now or you **MUST** pay a SINGLE EVENT MEMBERSHIP FEE at \$40 per person. Exception: Junior exhibitors in Walk-Trot/Jog and Lead line Classes only are exempt from the above requirements. Affidavits are not available. (Exception: All Breed entries)
7. Enclose a Valid Check or Money Order or completed and signed Credit Card Form. **ENTRIES WILL NOT BE ACCEPTED OR PROCESSED UNLESS ACCOMPANIED WITH TOTAL AMOUNT DUE FOR ENTRIES.** Entries received with partial entry fees WILL be returned to the exhibitor. Exhibitor is responsible for ensuring that the entry is properly postmarked. Postage meter dates are NOT ACCEPTED; envelope must have an official post office cancellation. Entries are encouraged by July 20, 2026.

ENTRIES WILL NOT BE PROCESSED OR ACCEPTED UNLESS ACCOMPANIED WITH TOTAL FEES, REGISTRATION PAPERS AND MEMBERSHIP CARDS. Entries received with partial entry fees will be returned to the Exhibitor and not processed until money accompanies entry form

AHA MEMBERSHIP REQUIREMENTS – Copies of ALL trainer's, driver's, rider's and at least one Owner's current AHA *Competition Level* Membership Cards MUST be included with the horse show entry form at the time of the entry. Any owner, trainer, driver, rider who exhibits horses in the show arena or signs the entry form as the responsible person for any individual's horses at the show must be a current member of AHA at the time of entry and at the time of showing. (Exception: All Breed class entries)

A *Single Event* Membership Fee of \$40 PER PERSON may be paid if not a current member of AHA. You may join the Comstock Arabian Association/AHA at this show. AHA MEMBERSHIP IS REQUIRED except for Lead line, Walk-Trot/Jog riders and ALL BREED entries.

ADDING CLASSES – Classes may be added to a horse's or rider's entries by 6 p.m. Friday night by email (Comstockarabianassociation@yahoo.com). For the Saturday afternoon session, classes may be added to a horse's or rider's entries prior Saturday morning up to 11:00 a.m. NO POST ENTRIES WILL BE ACCEPTED ONCE THE SESSION HAS STARTED.

ADMISSION TO ARENA – No person will be permitted to enter the arena except participants in the class, judges and their assistants and show officials. Attendants and grooms may enter the arena only when summoned by order of the judge. In all cases which require grooms or other assistants, PROPER ATTIRE IS REQUIRED.

AGE OF HORSES – For horse show purposes, any horse shall be considered to be one year old on the first day of January following the actual date of foaling. A JUNIOR horse is one that is 5 years old and under.

AGE OF RIDER – Age of rider is determined as of December 1, 202.

AMATEUR OWNER FAMILY DEFINITION – Please see USEF GR123, GR140, and AR110.4.a-f. Horses entered in AMATEUR OWNER and JUNIOR OWNER classes must be registered in the name of competitor or member of competitor's family. Leased horses not eligible.

□\*TWO DISTINCT NON-FAMILY OWNERS MAY CO-OWN AND SHOW A HORSE IN JOTR or AOTR classes except that no family member or a professional may enter into this relationship. Both co-owners of horse must have current USEF Amateur membership. No Farm or Corporation co-owned horses are eligible (see USEF AR110 4e).

CANCELLATION OR DATE CHANGE OF SHOW – Show Management reserves the right to change the dates and/or the location of the show or to cancel the show altogether. In the event of a cancellation, all entry fees will be refunded. Office fees are non-refundable. Neither the Show Management nor AHA shall have any liability to any exhibitor, owner, handler or other person, firm or corporation by reason of any change or cancellation of the show, except for the return of the aforementioned fees.

DISCIPLINE – Exhibitors are warned that any act of discourtesy to the officials of this show on the part of the owner, lessee, trainer, groom, rider, handler or driver will disqualify the horse from adjudication. The management reserves the right to remove a horse, owner, lessee, trainer, groom, rider, handler or driver from the show without being liable for compensation or damages. Excessive use of the whip on any horse in a stall, runway, schooling area or arena or anywhere on the show grounds will result in disqualification of the horse.

DOGS – Dogs may be brought to the Show grounds but must be on a leash at all times.

FOOD SERVICE – Food items, which includes breakfast, lunch, snacks and drinks, will be available.

GATE RULE – Exhibitors are cautioned against entering the same horse in successive classes. The TWO-MINUTE call for a class will be enforced. It is the responsibility of the exhibitor to be sure that his/her horse is at the gate on time. Class calls must be considered a courtesy only. No protests will be upheld on the basis of a public address system malfunction. Gate holds and tack changes are approved ONLY when requested at least 3 classes before the hold.

INDEMNITY AND NO-RESPONSIBILITY CLAUSES – All entries are accepted with the understanding that the COMSTOCK ARABIAN ASSOCIATION ONE DAY VALUE SHOW and the COMSTOCK ARABIAN ASSOCIATION, RENO, ARABIAN HORSE

ASSOCIATION AND IRONWOOD EVENT CENTER will not be held responsible for any loss, damage or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee but solely at of the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, his agents or employees, or by an animal owned or exhibited by him, and shall indemnify the COMSTOCK ARABIAN ASSOCIATION SHOW and the COMSTOCK ARABIAN ASSOCIATION, RENO, ARABIAN HORSE ASSOCIATION AND IRONWOOD EVENT CENTER against any and all loss,

damages and liability thus occasioned, including but not limited to any and all legal costs including attorney fees, which may be incurred as a result thereof. The submitting of an entry from to the Show Secretary shall constitute an acceptance by each person signing of the provisions therein set forth.

JUDGES – If for any reason a judge fails to attend this show or perform his/her duties, the Show Committee reserves the right to substitute a judge for the one who is officially designated in the Prize list.

JUDGES AND STEWARDS COMMISSION The AHA Judges and Stewards Commission is responsible for handling written and signed complaints in relation to judges', stewards' and other show officials' conduct when filed by exhibitors, show officials, AHA members or others, and when accompanied by a \$10 filing fee (Res. 5-90). Other comments, compliments, questions or inquiries are encouraged when appropriate (no filing fee required). JUNIOR EXHIBITORS – To be eligible, riders must not have reached their 19 birthday as of December 1 of the current competition year. The age of an individual on December 1 will be maintained throughout the entire competition year. Persons born on December 1 assume the greater age on that date. Junior exhibitor's name, address and birthdate along with parent's signature must appear in the "Minor Permission" area on the entry form for all juniors exhibiting in this show.

LOCATION OF CLASSES – The management reserves the right to hold classes, or portions of classes, on the grounds in another location or outside the main arena if it is found necessary to do so. Exhibitors will be notified and changes will be posted in the show office.

ORDER OF GO Trail and Ranch Riding Order of Go will be drawn by horse name by the show office staff and will work in consecutive order.

PROTESTS - Should any questions or disputes arise, they must be protested in the manner prescribed, be in writing and received by a member of the Show Committee, Competition Manager or Show Secretary within 48 hours of the alleged violation, accompanied with a deposit of \$200.

REFUNDS AND CANCELLATIONS – To encourage early entries, the Management agrees to cancel and refund entry fees on any horse not fit to show providing written notice is given to the Show secretary on or before entry closing date of July 20, 2026. Horses may be scratched from the show at the owner's option. Refunds will be considered from any horse suffering from illness or injury upon the presentation of veterinarian's certificate to the Show Secretary PRIOR to the start of said show. Request of any refund due to the illness or injury of the exhibitor will be considered and will be subject to the Management's decision. ALL REQUESTS MUST BE IN WRITING, ACCOMPANIED BY VETERINARIAN'S CERTIFICATE OR DOCTOR'S LETTER AND MUST BE RECEIVED BY THE SHOW SECRETARY PRIOR TO THE START OF THE SHOW. On approved refunds, only class fees will be refunded. No refunds will be made on drug fees or office fees. No refunds will be considered for requests received after the start of the show. Substitution of horses will be permitted.

REGISTRATION PAPERS REQUIRED – A copy of the FRONT AND BACK of the current registration papers showing proof of ownership MUST be submitted with the entry form at the time of making an entry. The copies will be returned in your show packet. (All Breed entries are exempt).

Horses entered in an Amateur Owner or Junior Owner class MUST be registered in the name of the competitor or a member of the Competitor's family. Horses registered in a farm/partnership/corporation name may be shown in Amateur Owner classes provided the family is the sole owner of the farm or entity. The sale of a horse does not eliminate this registration requirement. Contract of Sale or Bill of Sale will NOT be accepted.

### REGISTRATION REQUIREMENTS

Arabian Horses – Horses shown in this division must have been issued a certificate of registration from the Arabian Horse Registry of America, Inc. and/or the Canadian Arabian Horse Registry, or if under one year of age, be eligible for registry and registration applied for and must be entered under their full registered name. (Only weanlings that have had registration applied for may show without registration papers). Half Arabian Horses – Horses shown in this division must have been issued a certificate of registration from the Arabian Horse Association in the Half-Arabian or Anglo-Arabian Registry, or have been issued an Arabian Horse Association (Canadian Partbred Arabian Register) CPAR PERMIT, or if under one year of age, be eligible for registry and registration applied for and must be entered under their full registered name.

RESOLUTION 9-90 FEE - Judges & Stewards Educational Fee of \$5.00 per horse entered will be charged at all AHA Recognized Shows.

RIBBONS Regular Classes –Ribbons first through fifth. Junior Exhibitor Classes - Ribbons first through eighth.

SCRATCHING OR CANCELLING CLASSES – Exhibitors are requested to complete an "Add/Delete Class" form in the show office when it is necessary to scratch or cancel an entered class. The gate person may not take cancellation information. Please see the show secretary prior to the beginning of the scratched/cancelled class.

SHARPS CONTAINERS – Competition Management shall place sharps containers for the disposal of needles and other disposable sharp instruments in convenient locations on the show grounds. It is the Competition Management's responsibility to dispose of them properly. Competition Management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

SHOW OFFICE AND REGISTRATION – Registration at the Show Office by the exhibitor is required. The show office will be open at 7:00 a.m. on Saturday, August 1. The Show Office will be located inside the Event Center Main Building.

VETERINARIAN - The Show Management reserves the right to refuse entry onto the show grounds to any horse exposed to, or which may be harboring a communicable disease. Veterinary Health Certificate, Negative Coggins Test and Horse Transportation Permit are required for all horses entering into and traveling in the State of Nevada. I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, leasee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor.
